Other cats are not permitted.</li> </ul> <b><u>Cat Health &amp; Safety Requirements</u></b> <ul style="list-style-type: none"> <li>• Cats must be fully vaccinated and free from fleas, ticks, or contagious illnesses.</li> <li>• Cats must be transported in a proper carrier when arriving and leaving the venue.</li> <li>• Owners are fully responsible for their cat's behavior, safety, and cleanliness throughout the Event.</li> <li>• Aggressive or disruptive behavior will not be tolerated, and the Organiser reserves the right to remove any Participant and their cat from the Event.</li> <li>• Participants must keep their cats on a leash or in a carrier when not in a designated play area.</li> </ul> <p>All Participants must adhere to the Venue's policies, any consumption of food and beverages from outside may not be allowed.</p>

## **Conditions of Entry**

### **1. Introduction**

1.1 These Conditions of Entry are to be read in conjunction with the Schedule to Conditions of Entry. In the event of any inconsistency between these Conditions of Entry and the Schedule, the provisions of the Schedule shall prevail. Together, these documents constitute the "Terms and Conditions" governing participation in “The Fancy Feast Experience” event.

1.2 The Organiser reserves the right, at its sole discretion and without prior notice, to amend the Terms and Conditions at any time, including but not limited to changes in the event schedule, entry criteria, prize details, or cancellation of the event. Participation in the event constitutes acceptance of these Terms and Conditions, including any future revisions.

1.3 The Organiser’s decisions on all matters related to the Event—including eligibility, participation, and the distribution of gifts and prizes—are final, binding, and not subject to appeal or correspondence.

### **2. Event Registration**

2.1 By submitting an RSVP to attend “The Fancy Feast Experience”, participants confirm that they have read, understood, and agree to be bound by the Terms and Conditions.

2.2 All costs and expenses associated with attendance at the Event—including but not limited to transportation, cat supplies, and personal expenses—shall be borne solely by the participant.

2.3 Submission of an RSVP does not guarantee acceptance. Only those who receive an official confirmation from the Organiser will be granted access to the Event.

2.4 The Organiser is not responsible for any technical or communication failures that may affect the submission or receipt of the RSVP.

### **3. Eligibility**

3.1 The Event is open to all individual legal residents of Malaysia aged 21 years and above. The Organiser reserves the right to request proof of eligibility, including identification documents, as a condition of participation.

3.2 Employees of the Organiser and its affiliated companies, and immediate family members of such employees, are not eligible to register for the Event.

### **4. Disqualification**

4.1 The Organiser reserves the right to disqualify any participant who:

- 4.1.1 Provides inaccurate, incomplete, or misleading registration details;
- 4.1.2 Submits multiple or fraudulent entries;
- 4.1.3 Violates any part of the Terms and Conditions;
- 4.1.4 Behaves in a manner deemed unsafe, disruptive, or inappropriate at the Event.

4.2 In cases where a disqualification occurs after the issuance of gifts or prizes, the Organiser reserves the right to revoke or reclaim such items.

## **5. Gifts & Prizes**

- i) Injuries caused by one cat to another;
- ii) Property damage caused by cats;
- iii) Emotional or physical distress suffered by cats or owners.

6.4 The Organiser reserves the right to deny entry or remove any cat that poses a health or safety risk, at its sole discretion.

## **7. Publicity**

7.1 The Organiser may use a Participant's entry including without limitation, photos, drawings, text, and any other content or information submitted for purposes of the Event (collectively the "Materials"), and the Participant's name, and/or likeness, for advertising, publicity and Event of any goods or services of the Organiser, for an unlimited time throughout the world without compensation, and in any media. The Participant shall do all things necessary to give effect to this if requested by the Organiser.

The Organiser has the right to use and modify such materials or works in any way it deems fit without compensation to the Participant and the Participant waives all rights he or she may have in such materials or works.

## **9. Indemnity**

9.1 Each Participant agrees to indemnify, release and hold harmless each of the Organiser, its holding, subsidiary or related companies as defined in the Companies Act 2016 ("Nestlé Malaysia Group"), directors, officers, employees, agents, sponsors and/or representatives against any and all losses, rights, claims, actions and damages (including special, indirect and consequential damages) arising from or incurred as a result of the Participant's participation in the Event, acceptance of any Prize, and/or the use of the Participant's entry and/or likeness in connection with the Event or violation of the Terms and Conditions,
